Expressions : The parties above referred, which expression shall unless the contest does not so admit, include them the executors, administrator, members, officials responsible post holders and management committee and authorized agent including power of attorney.

WHEREAS Party No.2 i.e St.Lukes Hospital College of Nursing is conducting GNM and B.sc Nursing Course in a suitably equipped reputed general Hospital of its own having a facility of hundred beds namely St.Lukes Hospital, for the training of students.


AND WHEREAS Party No.2 i.e St.Lukes Hospital feels and finds that the availability of hundred beds hospital is insufficient for the purpose of providing training and additional clinical training for the students is required.

AND WHEREAS Party No.2 through its appropriate authority requested the appropriate authority of Party No.1 i.e Center Head, Medicovert Hospital,

Gunjal Wadi, Sangamner to permit the party No.2 to use 110 beds available with Party No.1 i.e in Medicovert Hospital Sangamner as well as every other requisite facility available in the said hospital for being utilize by the students of said institute of party No.2 for additional clinical training.

AND WHEREAS the Party No.1 i.e Center Head, Medicovert Hospital, Sangamner, through its appropriate authority has agreed and given his full permission with all legal and necessary requisite procedure for permitting the Party No.2 i.e St.Lukes Hospital College of Nursing Shrirampur, to utilize the said beds within their





Center Head, Medico Hospital, Sangamner (Short particulars of description of these given beds is given in the second schedule in detail under an mutual agreement including certain written terms and conditions agreed between the Parties hereto).

Therefore both the parties i.e Party No.1 and party No.2 do hereby undertake and agree .....

- i) The Party No.2 undertakes and agree that the said 110 beds which are made available by party No.1 under this agreement will be used for the purpose of teaching its students only and for no other purposes whatsoever.
- ii) That both the parties fully acknowledge that this agreement being executed shall not confirm on Party No.2, its staff, students of the institute any right other than those hereby expressly granted under the terms and conditions of the agreement.
- iii) That the Party no.2 do hereby agrees that during the period of this agreement the students of the institution who will be within the premises of the hospital of Party No.1 shall be subject to the disciplinary control of party No.1.
- iv) That it is also firmly and mutually admitted, understood and agreed by Party No.1 and Party No.2 that, during the posting of final year students of GNM and B.Sc of the institute of Party No.2 they will not take any kind of responsibility of the patients care, administration of medication and any treatment or procedure by themselves or at their own instance or will. It shall be carried out only and only under the authority,





recommendations, supervision and actual guidance of the staff or appropriate eligible authority of party No.1 Medcover Hospital, Gunjal Wadi, Sangamner. It is made abundantly clear in the agreement itself that since the students are in a phase of themselves under training and education they will not be directly or indirectly in a position to any decision regarding health of the patient unless the same has been specifically dictated and authorized by the appropriate authority, eligible professional of Party No.1.

- v) That the Party No.1 also undertakes that the final year students who have completed their academic qualification of theory and practical in the parent hospital (Party No.2 St.Lukes Hospital) will be provided with food (breakfast, Lunch & Dinner) and accommodation during their services to Medcover Hospital by Party No.1.
- vi) That the party No.1 also undertakes that the final year students described supra in Clause No.(v) Supra will be posted on 15 days in a month by suitable rotation so as to avoid overtime duties as they will be in a phase of preparing for their final year examination of Maharashtra University of Health Sciences.
- vii) That both the parties mutually agree and undertake that during the entire posting of students for practical training (B.Sc 2<sup>nd</sup> and 3<sup>rd</sup> year) the faculty lecturer/clinical instructor will accompany the students for day to day supervision and guidance during their training at Medcover hospital.
- viii) That the Party No.2 agrees and undertake that it will ensure that the student Nurses attending the hospital for training at Party





No.1 attends regularly and in time as pre-planned schedule, unless the same becomes unavoidable by the reason of any event beyond the control of human being, or capacity, illness, accident, natural calamities, marriage, death of relative or near and dear ones, God's act or any such eventualities of the like nature.

- ix) That the Party No.2 agrees and undertake that it will not claim any type of fund or grant from the Party No.1 for and against the educational activity carried out by way and as described in this agreement.
- x) That the Party No.2 agrees and undertake that it will utmost care and caution that its students will use the property of the hospital in every ordinary good and sane and responsible manner and will also abide by the disciplinary rules imparted by the Party No.1. The students/trainee will also keep the hospital and premises of Party No.1 neat and clean so far as it falls within their activity of training and area of accommodation.
- xi) That the Party No.2 agrees and undertake that the students posted as well as students seeking training will not bring or allow with them any third parties or strangers or visitors etc. nor will they carry with themselves any hazardous or health affecting or objectionable thing or article or material inside the hospital premises of Party No.1.
- xii) That the Party No.2 agrees and undertake that during the posting/training of students the affiliation fees of these eligible students/trainees will be paid by Party No.2.





xiii) That the Party No.2 agrees and undertake that this agreement will be valid for 2 years from the date of commencement of the actual training/posting of the students by Party No.2 with Party No.1.

xiv) That the Party No.1 agrees and undertake that since the student nurses posted or seeking training are females the responsibility of protection of their life, limb and security with dignity and their modesty will be that of Party No.1. and party No.2

Both the parties to the agreement do hereby agree that in case of arousal of any dispute between parties hereto the agreement the Competent Court establishments of place Shirampur will solely and exclusively have every legal jurisdiction.
